# BOARD OF DIRECTORS' MEETING Wednesday, November 15, 2017 Closed Meeting at 5:00pm / Open Meeting at 6:00pm Buttermaker's Cottage

- 1) Call to Order/Pledge of Allegiance Chairwoman Peirce called the meeting to order at 5:00pm. Vice Chair Bryant led the attendees in the Pledge of Allegiance.
- 2) Roll Call Nancy Peirce, Chair, Present; Cliff Bryant, Vice Chair, Present; Jim Driver, Present; Dan House, present; Chris Harris, present
- 3) Adjourn to Closed Meeting The Board adjourned to a closed session at 5:10pm to discuss:

a) Pleasant Valley School acquisition

- b) Employee Performance Evaluations and Merit Compensation
- Adjourn to Open Meeting The Board adjourned to the open meeting at 6:00pm.
- Report from Closed Session There was no report from the closed session.
- 6) Introduction of guests No public guests were present.
- Agenda Approval Order of agenda items was discussed. Director Harris moved to approve the agenda as presented.
   Director House seconded the motion. Motion passed unanimously.
- 8) Public Comments There were no public comments.
- 9) Minutes The minutes from October 18, 2017, were discussed. Director House moved to approve the minutes as presented. Vice Chair Bryant seconded the motion. The motion passed unanimously.

#### 10) Old Business

- a) Memorial Bench Policy The Board discussed reinvigorating the "Memorial Brick" program in lieu of Memorial Benches. The Board agreed that more research needs to be completed.
- b) Resolution for revision of audit calendar Chairwoman Peirce notified Supervisor Hank Weston that a resolution revising Western Gateway's audit calendar from annual to every-5-years would be forthcoming. The Board discussed resolution 17-02 toward this end. Director Driver moved to adopt resolution 17-02. Vice Chair Bryant seconded the motion. The motion passed unanimously.

#### 11) New Business

- a) Policy for Deposit Refunds on Reservation Cancellations The Board discussed creating a financial penalty for those parties that wish to cancel their confirmed reservations. Current contract language makes no provision for such penalties. The Board agreed that a graduated penalty relative to the date of cancellation should be implemented.
- b) Resolution to Purchase PVS Vice Chair Bryant moved to table the vote on the resolution subject to the call of the Chair of the Board. Director House seconded the motion. Motion passed unanimously, though Director Driver recused himself from the matter.

#### 13) Financial

a) Review & approve financial reports for October 2017 - Chairwoman Peirce indicated that WGR&PD is moving into a "crunch period" prior to receiving a tax distribution from the county. Vice Chair Bryant moved to approve the financial reports of October 2017. Director House seconded the motion. Motion passed unanimously.
